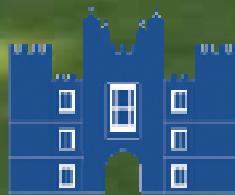

2010 GOLF SOCIETY PACKAGES



Featured in golf monthly's "**Must Play Courses**", Hampton Court Palace Golf course has two tales to tell. At 6514 yards in length and par 71, the course has a parkland front nine and a contrasting links feel to the back nine, particularly with the breeze up.

Course designer Willie Park, who's most famous creation was Sunningdale Old Course, did not create too many easy golf courses and Hampton Court Palace is no exception to this rule.

The course bares all Park's design hallmarks, slightly raised greens with imaginative contours, gently undulating fairways, strategically placed bunkers and fairways flanked by flowering grasses during the summer months. It is from the

preservation of this heritage, that the golfer will find so much more at Hampton Court Palace Golf Club.

The course itself opens up with three relatively straight forward Par 4's, which will lure the unsuspecting golfer into a false sense of security. From here the course throws down its challenge by ensuring players of all abilities are tested to the full, especially in their shot making. With three finishing holes that rank amongst the best in golf, the course is both challenging and beautifully unique.

Hampton Court Palace golf club is the ideal venue for both Golf Societies and Corporate Golf Days. Set in the grounds of Hampton Court Palace, the course provides a mixture of inland links and parkland golf with stunning views of the palace and a herd of free roaming Fallow deer.

The course will test the regular golfer and yet still be sympathetic to those new to society golfing. The experienced staff will be on hand to provide you and your guests with the level of service that you would expect from a prestigious venue.

We have a number of variations on breakfast, lunch and supper/dinner, so you can tailor the day to our needs.

We have created some standard packages that will give you an idea of the costs for your society days at Hampton Court Palace G.C, however all of these can be modified to suit your particular requirements.

Golf Day Etiquette

The management and members of Hampton Court Palace Golf Club expect all guests and visitors to maintain a reasonable standard of dress at all times whilst on the course and in the club house

DRESS STANDARDS

- Both Men and Ladies are kindly requested to observe the following dress code both on & off the golf course:
- Correct golf footwear
- Shirts with collars (mock-necks allowed)
- Shirts must be tucked in
- No non-golf related sport shirts
- Tailored shorts & trousers only (No cargo or side pockets)
- No Denim
- No tracksuits or leisure leggings
- No 3/4 length trousers
- No tucking trousers into socks
- Caps to be worn in the correct manner
- No bandanas (No headwear to be worn in the bar/restaurant areas)
- Mobile phones for emergencies only
- Golfers must not share bags or clubs

Ladies:

- Tapered shirts can be worn out
- Capri 3/4 length trousers acceptable

Please do not be offended when asked to leave the clubhouse or the course if you fail to observe the proper dress codes and regulations.

Hampton Court staff have the final decision as to suitability of clothing and footwear

PLAYING GUIDELINES

Every effort is made to ensure a reasonable pace and standard of play. To achieve this where possible our policy is to pair up all groups into 4-balls. (1,2 or 3-Balls do not have priority) Please would all groups only call through a faster group if there is room to play into. To assist speed of play we encourage any player to play a provisional rather than walk back to the tee.

SPEED OF PLAY - The following is an indication of the time four-balls are expected to be completed on the course in 4 1/4 hours

Thank you for your co-operation.

CLUBHOUSE

- Smart casual wear only will be permitted in the clubhouse.
- No baseball caps or hats should be worn in the clubhouse.
- No sports shorts or beach shorts. Tailored shorts only.
- Footwear must be worn at all times.
- Mobile phones are banned from the clubhouse.
- Under no circumstances should golf shoes or wet / muddy golf clothing be worn in the clubhouse.

Golf Day Terms and Conditions

GOLF DAYS

1. A golf day or society booking is for a minimum of eight full paying players. Any variation from this will be at the sole discretion of the Club.
2. There is a 4 ball policy in operation throughout the year and 2 or 3 balls may be required to pair up.
3. A provisional booking is made on completion and submission of a booking form to the Club at which you are planning to have the event.
4. The following rule only applies to Crown Golf Members. Please note the Open Play membership benefit cannot be used as part of your Society event, as detailed on www.crown-golf.co.uk. Members of Crown Golf Clubs are liable to pay the full event price.
5. Please ensure that players adhere to club dress codes – both course and clubhouse. Further information on dress code is available on request from the club in advance of your booking.

DEPOSIT PAYMENTS

6. All bookings require a deposit within 14 days of the provisional booking. If the event occurs less than 14 days from booking the deposit is required at time of booking.
7. All bookings require a deposit, unless the Customer has an account with the Club with a unique reference number, supported by a Purchase Order number.
8. Bookings are provisional until receipt of appropriate written confirmation or deposit and signed copy of these terms and conditions. The Club reserves the right to cancel any booking without liability in the event of non-payment of a deposit.
9. Deposits are non-refundable except under circumstance defined in section 14.
10. A deposit of £10 per person is required at the time of booking for events with a total value under £500. For events with a total value greater than £500 the Club reserves the right to request a higher level of deposit.

ARRANGEMENTS AND NUMBERS ATTENDING

11. The Customer must confirm to the Club all information necessary to organise the golf event including, the anticipated number of attendees and details of special dietary requirements and menu selections, not less than 14 working days prior to the golf event. Where a booking is made at less than 14 days notice, all such information must be confirmed at the time of the booking.
12. Final confirmed numbers are required no later than 3 days prior to the event.
13. **A** - Where the actual attendance on the day is 1 to 3 players less than the final confirmed numbers the Customer will be liable to pay for any pre ordered food & beverage but no green fee for the absent players.
B - In the event of 4 or more attendees cancelling, the customer will be liable to pay for the full green fee and any pre ordered food & beverage for the absent players.
14. The Club reserves the right to reallocate the golf event if the attendance differs significantly from the predicted number. The Club will give written notice of amendments prior to the event if given a reasonable notice period of changes by the Customer. The Club reserves the right to make any necessary amendments to the proposed menu or facilities.

CANCELLATION

15. Cancellation charges are based upon the Customer's most recent confirmation.
16. In the event of cancellation prior to an event the charges are as outlined in the matrix below.
8 days or more prior to the golf event = All deposits lost or event transferred to a future date
7-0 days prior to golf event = Full balance payable
17. The Club will make every attempt to resell cancelled booking space/times and use the profit in calculation of cancellation charges.
18. The Club may, at its sole discretion, cancel at any time any golf event it deems may prove unsuitable or disruptive to the Club as a whole. Although not bound to do so the Club would, if permitted, offer a minimum of 48hrs notice in consideration of the Customer's need to amend arrangements. In such event the Club will refund all monies paid in advance by the Customer and shall be deemed to have no further liability arising from the cancellation. In the event that a Customer is found to have misrepresented the nature of an event, the Club reserves the right to cancel the event without refund of monies paid in advance.

PAYMENT

19. For all bookings payment is to be made in full no later than the day of the event prior to the first tee time.
20. The Club is not liable to offer reductions or reimbursement in the event that weather affects your golf day in any way whatsoever excluding section 14.
21. The Customer agrees to take full responsibility, and reimburse the Club, for the cost of repair arising from any damage to the property, contents or course and grounds by the players in their golf society.
22. All prices quoted include VAT unless otherwise stated.

CONTRACTED SUPPLIERS

23. If independent suppliers are authorised by the club the Customer is responsible for ensuring the correct health and safety and public liability in held by that supplier.

Adjustment to any of the above terms and conditions are at the sole discretion of the General Manager. Any changes must be stated on the booking form overleaf and only apply for the duration of that event. The Club reserves the right to revise quotations where prices may be affected due to reasons beyond its control and in such event will do so in writing to the Customer.
